### **COVIVIO AWARDED THE "GRAND PRIX SPECIAL DU JURY" AT THE CEREMONY OF THE "GRAND PRIX DE L'ASSEMBLEE GENERALE 2018"**

*The 12<sup>th</sup> July, Covivio was awarded the "Grand Prix Spécial du Jury" (Jury's Special Grand Prize) at the ceremony of the "Grand Prix de l'Assemblée Générale 2018" (2018 General Meeting Grand Prize) held within the scope of the International Financial Forum of Paris EUROPLACE.*

Created in 2005, the Grand Prix de l'Assemblée Générale is coordinated by the Institut du Capitalisme Responsable (Institute for Responsible Capitalism). Its purpose is to encourage and showcase companies' best AGM practices in terms of shareholder dialogue, governance and CSR, by stressing the importance of presenting these aspects to their shareholders in a clear and comprehensible way.

The Grand Prix de l'Assemblée Générale targets the General Meetings of all companies in France's CAC 40 index and 20 companies in its SBF 80 index.

This prize was awarded to Covivio by a jury of personalities from France's financial community and large corporations, in recognition of the quality and relevance of the information presented at Covivio's General Meeting of 19 April this year. The award was presented to Covivio Chief Operating Officer Yves Marque by Paris EUROPLACE General Delegate Arnaud de Bresson.
